Pursuant to Section 4 of the Natural Gas Act ("NGA") and Part 154 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations, and in compliance with the Commission order issued July 29, 2019, in Docket No. RP19-941-000, *et al.*, ("July 29 Order"), Gas Transmission Northwest LLC ("GTN") respectfully submits for filing revised Section 6.41 to be part of its FERC Gas Tariff, Fourth Revised Volume No. 1-A ("Tariff"). GTN respectfully requests that the Commission accept revised Section 6.41, included herein as Appendix A, to be effective August 1, 2019.

Statement of the Nature, Reasons and Basis for Filing

To comply with FERC Order No. 587-Y,⁴ on March 28, 2019, in Docket No. RP19-941-000, GTN filed a revised Section 6.41 to reflect the implementation of the most recent North American Energy Standards Board (NAESB) Standards, Version 3.1 ("Standards"), to become effective August 1, 2019 ("March Filing"). In its July 29 Order, the Commission accepted GTN's March Filing to become effective as proposed, subject to further review and conditions as described herein.

In its March Filing, GTN requested certain revisions to Section 6.41 in order to implement the Standards in accordance with Order No. 587-Y. In its July 29 Order, the Commission identified GTN as having a compliance obligation, and directed GTN to make two (2) modifications to Section 6.41, including: a) changing a reference from "1.3.2(v) GT&C – Nominations, 6.19.4(b), except as provided for in 6.19.4(b)(5) and 6.19.4(c) of these General Terms and Conditions" to "1.3.2(v) GT&C – Nominations, 6.19.4(b)"; and b) remove Standard 1.3.2(v) from the section titled "Standards for which Waiver or Extension of Time to Comply have been granted." 5

To comply with the Commission's directive, GTN is submitting in the instant filing revised Section 6.41 to modify its reference to Standard 1.3.2(v) in the "Standards not Incorporated by Reference

and their Location in Tariff' area of Section 6.41, and to remove the reference to Standard 1.3.2(v) from the "Standards for which Waiver or Extension of Time to Comply" area of Section 6.41.

GTN respectfully requests that the Commission grant all waivers of its regulations and GTN's Tariff to accept this filing and approve Section 6.41 to be effective as requested herein.

GTN requests that the Commission accept Section 6.41, enclosed as Appendix A, to be effective August 1, 2019.
