General Section 4 Rate Filing Errata and Supplement

## Dear Secretary Bose:

On September 29, 2023, Gas Transmission Northwest LLC ("GTN") submitted a general rate and tariff change filing pursuant to Section 4 of the Natural Gas Act ("NGA"), 15 U.S.C. § 717c(e), and Subpart D of Part 154 of the regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), 18 C.F.R §§ 154.301-315 ("September 29 Rate Filing"). Due to an administrative oversight, while GTN did file all supporting statements, schedules, and workpapers in native format, it inadvertently filed certain exhibits that did not preserve all links and formulas as required by Order No. 884. Therefore, GTN is refiling Exhibit Nos. GTN-0077 through GTN-0149 so that all supporting statements, schedules, and workpapers preserve all links and formulas. GTN notes that these updated exhibits contain the identical information GTN submitted in these exhibits as part of its September 29 Rate Filing and as such these updates have no impact on, and do not change, the cost-of-service or rates contained in the September 29 Rate Filing.

Lastly, GTN notes that as part of ensuring that all links and formulas were preserved across its cost-of-service statements and schedules as discussed above, it was required to add three additional workpaper data tabs to the Excel file it is filing today. GTN has designated these three additional data tabs as Exhibit No. GTN-0151 and notes that they have no impact on, and do not change, the cost-of-service or rates contained in the September 29 Rate Filing.
