Pursuant to Section 4 of the Natural Gas Act (“NGA”), Part 154 of the Federal Energy Regulatory Commission (“FERC” or “Commission”) regulations,¹ Rule 212 of the Commission’s Rules of Practice and Procedure,² and the Commission’s October 31, 2023 Order Accepting and Suspending Tariff Records, Subject to Refund, and Establishing Hearing Procedures in Docket No. RP23-1099-000 (“Suspension Order”),³ Gas Transmission Northwest, LLC (“GTN”) hereby submits as part of its FERC Gas Tariff, Fourth Revised Volume No. 1-A (“Tariff”) this Type 610⁴ motion to place the certain suspended tariff records that are not subject to modification into effect on April 1, 2024.

Statement of the Nature, Reasons and Basis for Filing

On September 29, 2023, in Docket No. RP23-1099-000, GTN filed revised tariff records pursuant to Section 4 of the NGA and Part 154 of the Commission’s regulations to implement a general rate case, propose a system-wide general rate increase, and included changes to GTN’s rates, rate schedules and General Terms and Conditions (“GT&C”) of its Tariff (“Rate Case Filing”). By its Suspension Order, the Commission accepted and suspended GTN’s tariff records to become effective upon motion April 1, 2024, subject to refund and the outcome of the hearing procedures established in the Suspension Order.⁵

GTN is submitting the instant filing to move those certain suspended tariff records not subject to modification, and listed in Appendix A, into effect April 1, 2024,⁶ consistent with GTN’s rights pursuant to Section 154.206 and the Suspension Order.

Motion to Place Tariff into Effect

Pursuant to Section 154.206 of the Commission’s Regulations and Rule 212 of the Commission’s Rules of Practice and Procedure, GTN hereby moves to place those certain suspended tariff records not subject to modification, and included herein as Appendix A, into effect April 1, 2024. GTN requests that the Commission grant any waivers necessary for the proposed tariff records to become effective as requested herein.
