Dear Ms. Bose:

On July 15, 2015, in Docket No. RP15-1119-000, Gas Transmission Northwest LLC (“GTN”) submitted revised tariff records<sup>1</sup> to its FERC Gas Tariff, Fourth Revised Volume No.1-A (“Tariff”), to comply with the Commission’s March 14, 2013, Order Issuing Certificate in Docket No. CP12-494-000, regarding the Carty Lateral Project recourse rates (“July 15 Filing”). In its July 15 Filing, GTN stated that it expected to place the Carty Lateral facilities into service on or about October 1, 2015, and requested that the Commission accept the revised tariff records to become effective on the date the facilities are placed in service. For administrative ease, the revised tariff records reflected an effective date of December 31, 9998, consistent with the FERC’s Implementation Guide for Electronic Tariff Filings.<sup>2</sup> GTN stated that it would provide notification to the Commission of the actual in-service date, which would be the effective date for the revised tariff records. On September 10, 2015, the Commission issued an order accepting the July 15 Filing and requiring that GTN submit this informational filing via eTariff when GTN submits its notice of in-service in compliance with section 154.4.20(c)(2) of the regulations.<sup>3</sup>
