Statement of the Nature, Reasons and Basis for Filing

Section 6.3.8 of Great Lakes' Tariff provides that Great Lakes will file an annual report on or before May 1 of each year reflecting the operational purchases and sales of gas for the preceding calendar year. The report shall state the source, date, volumes, price, costs and revenues, disposition of the associated costs and revenues, and an explanation of the purpose, for all operational purchases and sales transactions.

Great Lakes hereby advises the Commission that it made no operational purchases or sales of gas during the twelve-month period ending December 31, 2017. Accordingly, no reportable operational purchases and sales of gas occurred during this time period.
