Pursuant to Section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations¹ and in compliance with the Commission Order No. 587-AA filed in Docket No. RM96-1-043, *et al.*,² Great Lakes Gas Transmission Limited Partnership ("Great Lakes") hereby submits for filing certain tariff sections to be part of its FERC Gas Tariff, Third Revised Volume No. 1 ("Tariff").³ Great Lakes requests that the Commission accept the tariff sections, filed herein as Appendix A, to become effective August 1, 2025.

Statement of Nature, Reasons and Basis for Filing

On November 22, 2024, the Commission issued Order No. 587-AA, approving Version 4.0 of the Wholesale Gas Quadrant (“WGQ”) Standards (“Version 4.0 Standards”) adopted by the North American Energy Standards Board (“NAESB”). The revisions included in the Version 4.0 Standards are designed to promote greater efficiency in business processes and commercial transactions and strengthen cybersecurity protections of the natural gas industry. Natural gas pipelines were directed to submit their compliance filings by February 3, 2025, with an effective date of August 1, 2025.⁴ In compliance with Order No. 587-AA, Great Lakes has revised its Tariff section listed in Appendix A to reflect the incorporation of the updated data sets in the following Business Practice Standards:⁵


