General Section 4 Rate Filing Compliance Supplement

Dear Secretary Bose:

On March 28, 2024, Gas Transmission Northwest LLC (“GTN”) submitted its Type 580<sup>1</sup> compliance filing to place into effect, on April 1, 2024, updated tariff records originally contained in GTN’s Section 4 rate case filing submitted on September 29, 2023 in Docket No. RP23-1099-000 (“Compliance Filing”).<sup>2</sup> Due to an administrative oversight, GTN inadvertently omitted the appendix containing the plant in-service balances for each of its facilities revised to reflect the anticipated plant balances as of April 1, 2024 (“Appendix C”) from its Compliance Filing.

Accordingly, GTN is submitting this supplement to its Compliance Filing to fully comply with the Commission’s Suspension Order<sup>3</sup> and provide the inadvertently omitted Appendix C.
